Programs Extending the Day

Parents whose children attend TRS Early Childhood Center have the option to register for Programs Extending the Day. Registration is for the entire school year, beginning on the child's first full day of attendance. Programs Extending the Day follow the school calendar and school closures. Registration is on a first-come, first-served basis. Full Day programs are available only to children whose classes dismiss at 2:00 p.m.

Fees for Programs Extending the Day are in addition to base tuition rate, and will be divided into monthly payments and combined with your child's monthly tuition payments. Monthly rates shown assume 10 monthly payments; fewer monthly payments may be stipulated in tuition contract depending on date of enrollment.

Space is limited. Space permitting, mid-year enrollments are allowed. No refunds are offered for Programs Extending the Day.
