# Application for Admission Full Day Programs



Full Day programs are available to all children in 2s and older. Children in Full Day programs spend the day with their classes until dismissal, then enjoy an afternoon snack, rest time, and enrichment activities with their fellow Full Day students. 2s students enrolled in Full Day will spend their entire day at school with their same-age peers, while 3s and up are combined into mixed-age play groups.

Childcare will be offered to Full Day families for a limited number of school closures, at reduced hours (typically 9:00 a.m. to 2:00 p.m.) and for an additional fee. These additional days are subject to cancellation if a minimum enrollment is not met. Details about additional childcare will be shared with Full Day families in the weeks preceding a qualifying closure.

# Full Day - Full Year Program

Families desiring year-round childcare can now enroll in Full Day - Full Year! This program ensures childcare whenever the school is open, from **September 1, 2026 to August 14, 2027**, encompassing SY '26-27 and Summer Session '27's 8-week session. **Childcare is not available during school breaks or the periods between the school year and Summer Session.**

Childcare will be offered to Full Day families for a limited number of school closures, at reduced hours (typically 9:00 a.m. to 2:00 p.m.) and for an additional fee. These additional days are subject to cancellation if a minimum enrollment is not met. Details about additional childcare will be shared with Full Day families in the weeks preceding a qualifying closure.

## Programs Extending the Day Full Day Programs



Parents whose children attend TRS Early Childhood Center have the option to register for Programs Extending the Day. Registration is for the entire school year, beginning on the child’s first full day of attendance. Programs Extending the Day follow the school calendar and school closures. Registration is on a first-come, first-served basis.

Fees for Programs Extending the Day are in addition to base tuition rate, and will be divided into monthly payments and combined with your child’s monthly tuition payments. Monthly rates shown assume 10 monthly payments; fewer monthly payments may be stipulated in tuition contract depending on date of enrollment.

*Space is limited. Space permitting, mid-year enrollments are allowed; fees will be prorated. No refunds are offered for Programs Extending the Day.*
